ORDER:

In the circumstances reported by the Director General of Police, Telangana State, Hyderabad, in the letter first read above, the Government, after careful examination of the matter, hereby decided for creation of Telangana State Anti-Narcotics Bureau (TSNAB) unit with headquarters at Hyderabad with (7) Regional Narcotics Control Cells i.e. at Warangal, Nizamabad, Karimnagar, Sangareddy, Khammam, Mahabubnagar and Railways and (4) Narcotics Police Stations one each in Hyderabad, Cyberabad, Rachakonda and Warangal Police Commissionerates detaching the subject from Crime Investigation Department with the posts sanctioned vide G.O. fourth read above .

Accordingly, the following Notification shall be published in an Extra-Ordinary issue of the Telangana Gazette Dtd. 30.04.2023.

NOTIFICATION

In exercise of the powers conferred by clause (s) of section 2 of Code of Criminal Procedure, 1973 (Central Act 2 of 1974) the Government of Telangana hereby creates the Telangana State Anti-Narcotics Bureau (TSNAB) unit with headquarters at Hyderabad with (7) Regional Narcotics Control Cells i.e. at Warangal, Nizamabad, Karimnagar, Sangareddy, Khammam, Mahabubnagar and Railways and (4) Narcotics Police Stations one each in Hyderabad, Cyberabad, Rachakonda and Warangal Police Commissionerates detaching the subject from Crime Investigation Department with the posts sanctioned vide G.O.Ms.No.188 Finance (HRM-I) Dept., dt:27.12.2022 with effect on and from the date of issue of this notification.

2. The posts sanctioned for creation of Telangana State Anti-Narcotics Bureau (TSNAB) unit with headquarters at Hyderabad and other Auxiliary units vide G.O.Ms.No.188 Finance (HRM-I) Dept., dt: 27.12.2022 shall be adjusted to the above unit. The Organization status, functions, staffing Expenditure, logistics equipment etc are appended to the G.O as Annexure -I and Statements I - VII

3. This order is issued with the concurrence of Finance (HRM.I) Department vide U.O.No.980503-228/A1/HRM.I/2023 Dt:28.04.2023.

ANNEXURE- I

(To G.O.Ms.No. 27, Home (Legal) Department, dt: 30.04.2023)

1. Mission of Telangana State Anti-Narcotics Bureau: To combat drug trafficking comprehensively, including cultivation, production, transportation, smuggling, sale, purchase, possession or consumption of psychotropic substances, drugs and narcotics in the state of Telangana.

II. Organizational Structure of Telangana State Anti-Narcotics Bureau:

The Telangana State Anti-Narcotics Bureau shall be headed by an officer of the rank of Addl. Director General of Police/Inspector General of Police.

The Head of Telangana State Anti-Narcotics Bureau shall function as Head of Department for exercising the financial powers as required under article VI of APFC volume-1 and Appendix-1 of APFC volume-1. The Head of Account is 2055-Police, MH-117 Internal Security SH (06) Telangana State Anti-Narcotics Bureau.

Telangana State Anti-Narcotics Bureau shall be headquartered at Hyderabad with (4) Notified Narcotics Police Stations in (4) Major Commissionerates and (7) Regional Narcotics Control Cells comprising of (26) Narcotics Enforcement Wings (NEWs) at Commissionerate and District Level, including SRP Secunderabad. All these units shall operate under the administrative control of Director, Telangana State Anti-Narcotics Bureau.

The Telangana State Anti-Narcotics Bureau shall function under the overall supervision and control of the Director General of Police, Telangana.

The Organizational structure of Telangana State Anti-Narcotics Bureau at Telangana State Level shall be as indicated at **Statement- I**.

III. Jurisdiction of Telangana State Anti-Narcotics Bureau:

The Telangana State Anti-Narcotics Bureau shall have jurisdiction throughout the State of Telangana.

All departments/institutions in Telangana shall extend administrative, logistical and operational support to Telangana State Anti-Narcotics Bureau. All the narcotics related cases/responsibilities including the sanctioned strength and budgetary allocations, hitherto exercised by the Narcotics Cell of Crime Investigation Department, TS stands transferred to Telangana State Anti-Narcotics Bureau.

It is clarified that the creation of Telangana State Anti-Narcotics Bureau doesn't absolve the districts and its field units of their responsibility of controlling the menace of Narcotics in their jurisdiction. The Telangana State Anti-Narcotics Bureau will register and investigate cases independently and in association with the local police under the provisions of NDPS Act 1985 and other related laws. All units/ Districts/ GRP shall assist the Telangana State Anti-Narcotics Bureau in all aspects related to investigation.

IV. Functions of Telangana State Anti-Narcotics Bureau:

It shall serve as a Secretariat for the State Anti-Narcotics Task Force. It shall exercise powers of a Police Station within the meaning of Section 2(s) of the Code of Criminal Procedure, 1973, including powers to register, investigate and prosecute cases related to drug trafficking. An officer of the rank of Deputy Superintendent of Police shall be designated as the Station House Officer in the Narcotics Police Station. It can also take up investigation of narcotic drugs and medical drugs related cases from other Units on the instructions of the Director General of Police, Telangana.

V. Powers and Duties of Head of Telangana State Anti-Narcotics Bureau:

- a. He shall serve as the head of the state's Anti-Narcotics Task Force and Head of the Secretariat for Narcotics Co-ordination Centre (NCORD).
- b. He shall supervise the working of Telangana State Anti-Narcotics Bureau. He shall also guide and supervise the functioning of the Narcotics police stations and State wide Narcotics Cells.

- c. He shall work in coordination with the Commissioners of Police and Superintendents of Police, Government Railway Police and other police units and provide support in registration and investigation of cases related to narcotics.
- d. Proposals, if any, for approval to hand over, transfer and take over the investigation of any case related to offences under the above laws from the local police shall be made to the Head of Telangana State Anti-Narcotics Bureau.
- e. He shall supervise cultivation and generation of intelligence and maintain surveillance in accordance with the provisions of law, and plan and conduct of operations against drug offenders and organized criminals.
- f. He shall coordinate with NCB, various national and other states' agencies dealing with narcotics and medicinal drugs. He shall also coordinate with other departments in Telangana state in connection with narcotics.
- g. He shall commission or conduct studies/surveys and research to understand the various dimensions of the problem, effects of various counter-measures, global best practices and models in association with academic institutions, non-governmental organizations, Department of Medical and Health and submit recommendations to the Government for necessary policy changes, through the Director General of Police, Telangana.
- h. He shall have powers to engage personnel including outsourcing staff on need basis as per the prevailing rates of remuneration prescribed by the Government from time to time within the posts allocated in G.O.Ms.No.188 Finance (HRM-I) Department, dt: 27.12.2022.
- i. He shall have powers to engage domain experts from time to time, with prior approve of the Government.
- j. He shall have powers to permit members of the force to travel to anywhere in India in line of duty, including air travel, with prior approval of the Government.
- k. He shall perform such other duties as may be assigned by the Government and Director General of Police, from time to time.
- l. He shall have the power to constitute Anti- Drug Committees in educational institutions, issue time to time guidelines for the functioning of its activities and monitor them.

VI. Functional Components of Telangana State Anti-Narcotics Bureau:

At Headquarters, the Telangana State Anti-Narcotics Bureau shall have five functional components viz., (a) Investigation Monitoring and legal Wing (b) Documentation, Training and Awareness wing (c) Administrative and Logistics Wing (d) Technical Wing (e) State Task Force. The functions of Telangana State Anti-Narcotics Bureau Head Office is shown **Statement-II (A)** and the staffing pattern of TSNAB Head Office is shown in **Statement-III**.

Investigation, Monitoring and Legal Wing: It shall comprise units namely viz., (i) Police Station investigation monitoring unit and (ii) Courts & Prosecution monitoring unit.

Documentation, Training and Awareness Wing: It comprises (6) units namely viz., (i) NCORD Mechanism Unit, (ii) Foreigners Cell (iii) Drug Disposal (iv) Anti-Drug Committees (v) Documentation (vi) Police Station Coordination, DOPAMS, SIMS, NIDAAN, NCORD Portals etc.

Administrative and Logistics Wing: It comprises units namely Motor Transport, Control Room, Intelligence Department, Ministerial and Accounts staff.

Technical Wing : It comprises units namely viz., (i) Data Analysis unit, (ii) Social Media and Darknet, (iii) Financial Analysis, (iv) Digital Forensics, (v) Offenders Monitoring unit.

State Taskforce: It conducts operations and other tasks entrusted by Additional Director General of TSNAB.

VII. Auxiliary Units:

A. Narcotic Police Stations at (4) Major Police Commissionerates (Hyderabad, Cyberabad, Rachakonda and Warangal)

Narcotics Police stations shall be formed one in each (4) Major Police Commissionerates in the state viz., Hyderabad, Cyberabad, Rachakonda and Warangal. These Police Stations shall function under the overall supervision and administrative control of Director, TSNAB and functional control of respective Commissioners of Police, who shall extend all the necessary support to the Narcotics Police Stations. These police stations shall exercise powers of a Police Station within the meaning of Section 2(s) of the Code of Criminal Procedure, 1973. An officer of the rank of Deputy Superintendent of Police shall be designated as the Station House Officer.

The functions of Narcotics Police Stations are indicated in **STATEMENT- II**. The Organization Chart for these Narcotics Police Stations are indicated **Statement-IV** and their Jurisdiction shall be respective commissionerates. The staffing pattern of Narcotics Police Stations shown in **Statement-V**.

B. Regional Narcotics Control Cells :

Regional Narcotics Control Cells shall be formed one in each (07) Regions namely Warangal, Karimnagar, Nizamabad, Sangareddy, Khammam, Mahabubnagar and Railways comprising of (26) Narcotics Enforcement Wings (NEWs) are as follows:

These Narcotics Enforcement Wings (NEWS) shall function under overall supervision and administrative control of Director, TSNAB and the functional supervision of the respective Unit Officers of Commissionerates and Districts. There shall be seamless coordination with Telangana State Anti-Narcotics Bureau including the data sharing. They shall have the powers and duties for detection and coordinating the investigation of cases related to drug trafficking in their respective units.

The functions of Narcotics Enforcement Wings shown in **STATEMENT- II** the Organization Chart for these Narcotics Enforcement Wings (NEWS) shown in **Statement- VI** and their Jurisdiction shall be respective units. The staffing pattern of the Narcotics Enforcement Wings (NEWS) in each of the (26) Wings is as indicated in **Statement- VII**.

VIII. Functions of Narcotics Police Stations:

- a. Registering and Investigating cases related to narcotics on the basis of information received directly or as entrusted by the Commissioners of Police in the Commissionerates of Hyderabad, Cyberabad, Rachakonda and Warangal, where these units shall have powers of a Police Station.
- b. Generating intelligence related to narcotics through use of technical resources and field operations.
- c. Monitoring prosecution in close co-ordination with prosecutors.
- d. Supervising investigations of narcotics related cases registered at other Police Stations and issuing advisory to the Investigating officers, through the Commissioners or Superintendents of Police.
- e. Prepare and submit special and periodical reports to the Head of TSNAB and carryout instructions of the Head of Telangana State Anti-Narcotics Bureau under supervision of the Jurisdictional Commissioners or Superintendents of Police.
- f. Train police personnel involved in investigation and prosecution of narcotics related cases in the Commissionerates/Districts.
- g. Take steps to reduce demand of narcotics through awareness and educative programs in coordination and consultation with the Head of Telangana State Anti-Narcotics Bureau and enlist the support and participation of all the stakeholders.
- h. Participate in programs for rehabilitation of victims of drug abuse in association with other government and non-governmental agencies including the District Medical and Health Officer under the guidance of District Collector.
- i. Create Anti-Drug Committees (ADCs) in educational institutions in its jurisdiction.

IX. Functions and components of Narcotics Enforcement Wings:

The Narcotics Enforcement Wings (NEWS) shall have three functional components viz. Intelligence, Operational Wing and Investigation Support wing.

X. Intelligence Generation:

The state Intelligence Department shall provide inputs and supplement and aid Telangana State Anti-Narcotics Bureau's efforts through its technical and other assets and make available all necessary technical tools and platforms for use of the Telangana State Anti-Narcotics Bureau at State Level and Auxiliary Units for the purpose of collection, collation, analysis and exchange of narcotics-related intelligence.

XI. Formation of Special Courts:

A total of (04) special courts/Fast Track courts are to be created at (04) major police commissionerates viz Hyderabad, Cyberabad, Rachakonda and Warangal with the prior approval of the Government.

XII. Sanction of Posts.

Following number of consolidated posts is to be sanctioned for the Organization of TSNAB Head Office, Narcotics Police Stations and Narcotics Enforcement Wings.

XIII. Selection of the staff to TSNAB and Auxiliary Units and their tenure:

Head of TSNAB under the guidance of HOPF shall devise a selection process based on requisite parameters for the staff to be deployed at Telangana State Anti-Narcotics Bureau Head Office as well as the Narcotics Police Stations and Narcotics Enforcement Wings and eligible staff will be deployed strictly on deputation from various wings of State Police, FSL and Director of prosecution. Recruitment of outsourcing staff for all levels shall be done by head of Telangana State Anti-Narcotics Bureau. Cyber Investigators shall be recruited on outsource. Those personnel who are found suitable would have to successfully undergo induction training conducted by the TSNAB after screening and approval of Director, Telangana State Anti-Narcotics Bureau.

Tenure of all police executive personnel at Telangana State Anti-Narcotics Bureau Head Office and at Regional Level Narcotic Control Wings would be ordinarily for two years and under no circumstance shall be for more than three years.

XIV. Central Depository for Seized Items:

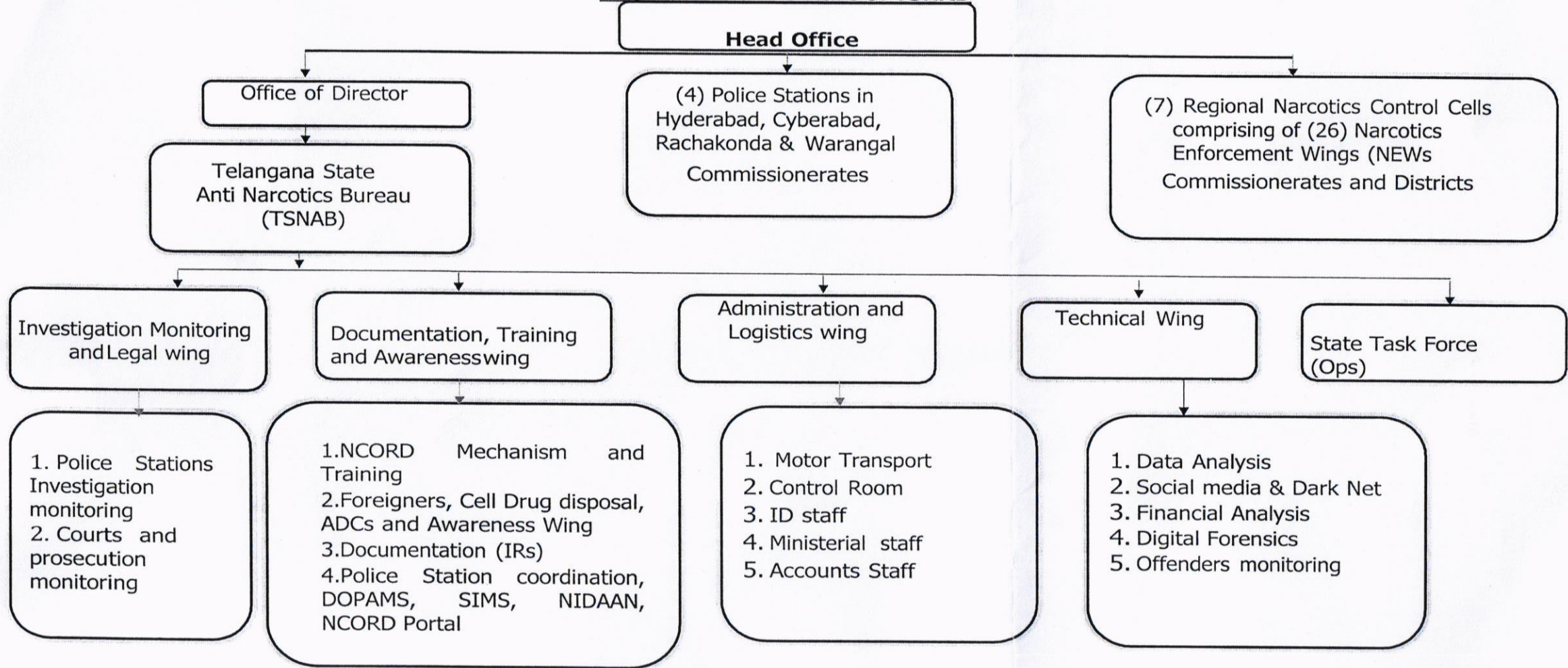
The Head of TSNAB shall establish a central depository for all seized drugs, narcotics and psychotropic substances and related items at Headquarters and at such other centres as deemed appropriate. He shall also devise a mechanism for their safe custody, documentation, management as well as their destruction in accordance with law.



**STATEMENT-II (To G.O.Ms.No. 27 Home (Legal) Department,
dt: 30.04.2023)**

A. Functional components of Telangana State Anti-Narcotics Bureau(Telangana State Anti-Narcotics Bureau)

1. Investigation support, Prosecution, Court Monitoring and Legal Wing:

These wing shall help in conducting fair and systematic investigations of narcotics related cases registered in other Police Stations of the Commissionerate or the District. The wing shall render and advise the legal assistance to the Investigating officers to file cases in the Courts of Law and closely monitor the prosecution of the cases all over the state including trials and other proceedings and take appropriate action in the interests of the state till the conclusion of the case.

2. Documentation, Training and Awareness Wing:

(i) These wing shall conduct screening tests, induction training for all the personnel inducted in the organisation in the matters related to drug trafficking and its prevention and also conducts the annual refreshing courses and other specialised trainings for all narcotics staff.

(ii) The wing shall be responsible for conducting and coordinating demand mitigation measures like public awareness and education programs, victim assistance and rehabilitation programs and any other measure on the directions of the Headquarters, Hyderabad and respective Police Commissioners/District Superintendents of Police.

(iii) This wing will collect IRs of all the offenders arrested throughout the country and develop database which will help the technical wing in data analysis.

(iv) This wing shall also have foreigners cell which collects foreign drug offenders and deportation data. This wing shall also collect data on drug disposals in the state. It shall also have a data of Anti-Drug Committees and monitor their activities.

(v) One of the wing's vital roles is to coordinate with Police Stations and other agencies connected with Narcotics, collect relevant documents, judgments, circulars etc and have access to DOPAMS, SIMS, NIDAAN and NCORD portals.

3. Administrative and Logistic Wing: this wing shall render administrative and logistical support, managing issue of pay, allowances, procurement, maintenance of accounts, housekeeping, transportation and other duties assigned by the head of Telangana State Anti-Narcotics Bureau. It will be also be responsible for the supervision of narcotics maalkhanas.

4. Technical Wing: The wing shall provide technical support to all the other wings and work in close coordination with the technical wing of the Headquarters, Hyderabad. This wing will perform Data Analysis, Finance Analysis, Digital Forensics, Social Media, Darknet and offenders monitoring and other technical matters.

5. State Task Force Wing: This wing shall work as a special unit to generate operational intelligence and conduct operations either independently or jointly with the Auxiliary units within their jurisdiction.

B. Functional Components of Narcotics Police Stations

1. Investigation, Prosecution and Monitoring: It shall conduct fair and systematic investigations of narcotics related cases registered in Police Stations of the Commissionerate and closely monitor the prosecution of the cases including trials and other proceedings and take appropriate action in the interests of the state till the conclusion of the case.

2. Awareness:

This wing shall be responsible for conducting and coordinating demand mitigation measures like public awareness and education programs, victim assistance and rehabilitation programs and any other measure on the directions of the Headquarters, Hyderabad and respective Police Commissioners/District Superintendents of Police.

3. Technical Wing: This wing shall provide technical support to all the other wings and work in close coordination with the technical wing of the Headquarters, Hyderabad. This wing will perform Data Analysis, Finance Analysis, Digital Forensics, Social Media, Darknet and offenders monitoring and other technical matters.

4. Operations: This shall work to generate operational intelligence and conduct operations either independently or jointly with the Auxiliary units within their jurisdiction register cases and carry out investigation.

C. Functional Components of Narcotics Enforcement Wings

- 1. Intelligence and Operations:** This shall work to generate operational intelligence and conduct operations either independently or jointly with the Auxiliary units within their jurisdiction register cases and carry out investigation.
- 2. Investigation support and Prosecution Monitoring:** It shall help in conducting fair and systematic investigations of narcotics related cases registered in their respective Police Stations of the Commissionerates or Districts and also monitor trails and prosecution.

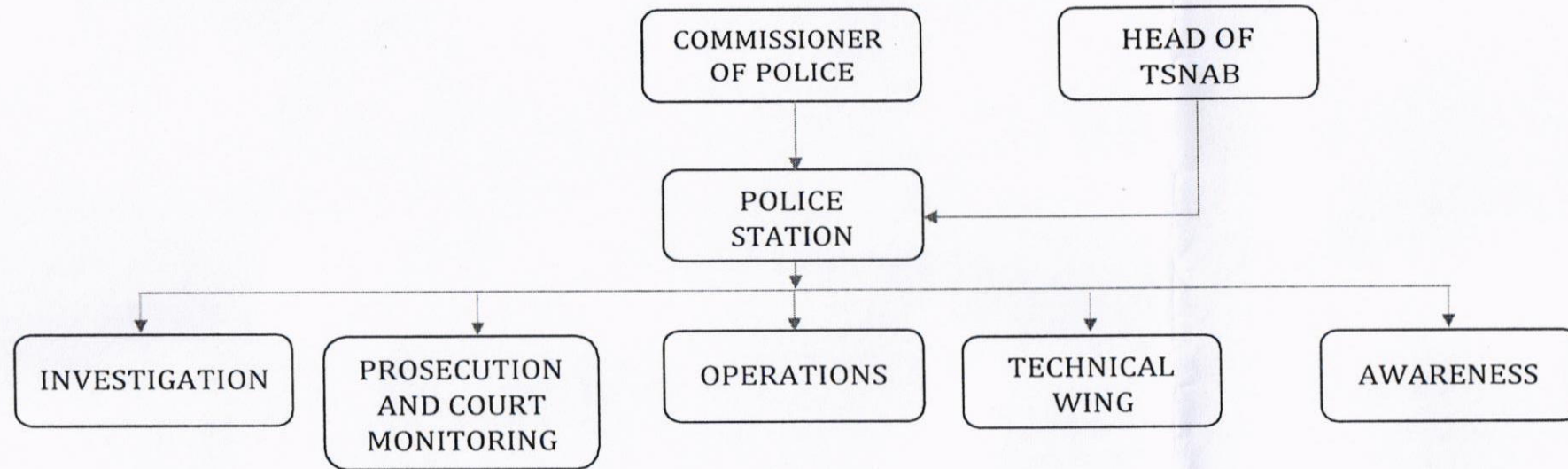

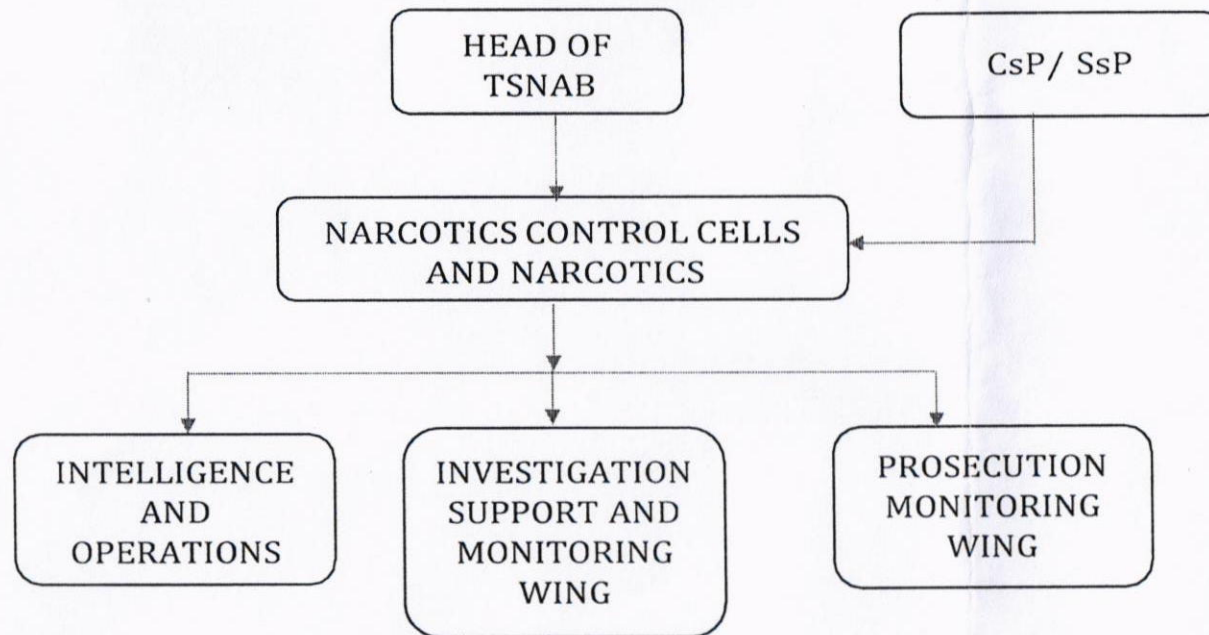


